The Moncks Corner Farmers Market is held weekly on Thursdays at the Market Pavilion 418 East Main Street at the Regional Recreation Complex.

- Market is 3-7pm, you need to be set up by 2:45pm and stay the duration.
- Vendor space priority is granted to growers.
- Spaces will be assigned to create the best flow for all participating vendors
- Flexibility is necessary, shifting of your location may happen day of.
- A Town of Moncks Corner Business license is required for all non-farmer/grower vendors.
- Space Information: 10x10, you will need to bring everything needed to sell your goods and services.
- Recommended supplies: Tents, tables, chairs, point of sale system, and signage. None of these are provided.
- When using a tent, you must use weights or anchors to keep it in place in case of sudden winds..
- The fees are: \$200 for the full season; \$35 per month; \$10 for a single market (Promotional/non-sales civic & nonprofits only)
- Indoor restrooms on site.
- Electricity and water are available.

Form must be completely filled out for consideration.
